

Invitation to Clas Ohlson's Q4 presentation and Capital Markets Day on 8 June

Clas Ohlson will publish its year-end report for 2021/22 on 8 June at 07:00 CET. A live presentation of the report will be held the same day in the store on Sveavägen 52 in Stockholm at 09:00 CET.
